A tax rate of \$0.195748 per \$100 valuation has been proposed by the governing body of SWEENY HOSPITAL DISTRICT.

PROPOSED TAX RATE \$0.195748 per \$100
NO-NEW-REVENUE TAX RATE \$0.356165 per \$100
VOTER-APPROVAL TAX RATE \$0.386270 per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for SWEENY HOSPITAL DISTRICT from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that SWEENY HOSPITAL DISTRICT may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that SWEENY HOSPITAL DISTRICT is not proposing to increase property taxes for the 2025 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 15, 2025 AT 6:00PM AT 305 N. McKinney Street, Sweeny, Texas 77480.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, SWEENY HOSPITAL DISTRICT is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Governing Body of SWEENY HOSPITAL DISTRICT at their offices or by attending the public meeting mentioned above.
